RESOLUTION NO. 622

A RESOLUTION OF THE BOARD OF COMMISSIONERS OF POINT ROBERTS WATER DISTRICT NO. 4, WHATCOM COUNTY, WASHINGTON, ESTABLISHING A LEAK ADJUSTMENT POLICY.

WHEREAS, the District Board of Commissioners reviewed the District's current leak adjustment policy and directed staff to incorporate revisions to such a policy into a District Resolution; now, therefore,

BE IT RESOLVED by the Board of Commissioners of the Point Roberts Water District No. 4, Whatcom County, Washington, as follows:

A leak adjustment policy shall be established pursuant to the following provisions:

Leak must be in-ground between water meter and entry point of water service into building

- 1. An application for a leak adjustment may be granted by the District Manager and shall be limited to no more than \$500.00.
 - 2. Approved Leak Adjustments shall meet all of the following criteria:
- A. A customer who experiences a leak in the customer's water systems serving a residential or commercial structure may request from the District an adjustment to billing for charges attributable to a leak by submitting a completed and signed District Leak Adjustment Application in the form attached marked Exhibit A and provide proof to the District's satisfaction that the leak has been repaired by enclosing a paid invoice or receipt for repair parts.
- B. The customer's leak must be in-ground between water meter and entry point of water service into building; no adjustments will be granted for internal plumbing leaks which are considered a household maintenance responsibility or weather related occurrences.

- C. Leaks in piping leading to and within a water feature or outdoor amenity such as but not limited to, an irrigation system, a pond, fountain, or swimming pool, or any water loss resulting from malfunctioning of systems within a water feature or outdoor amenity are not eligible for a leak adjustment.
- D. The customer must take action to repair the leak when District employees notify the customer regarding the possibility of a leak or when the customer discovers the leak. The water will be turned on when the leak has been repaired or such a time period as approved by the District Manager.
- 3. Only one Leak Adjustment application will be considered every five years per owner per account/property.
- 4. Approved Leak Adjustment amounts will be based on customer charges for one billing period only. The amount will be computed as 50% times the water volume charges for that billing period but no more than \$500.00.
- 5. Only the Board of Commissioners can approve additional adjustments if the Board determines in its discretion to do so.
 - 6. This resolution shall be effective the date set forth below.
